The Weights and Measures (Sale and Labelling of Goods) (Amendment) Rules, 2020.

(Under sections 33 and 43 of the Weights and Measures Act, Cap. 103)

IN EXERCISE of the powers conferred upon the Minister responsible for Trade by sections 33 and 43 of the Weights and Measures Act, these Rules are made this 5th day of February, 2020.

1. Title and commencement

- (1) These Rules may be cited as the Weights and Measures (Sale and Labelling of Goods) (Amendment) Rules, 2020.
 - (2) These Rules shall commence on the 14th day of August, 2021.

2. Amendment of the Weights and Measures (Sale and Labelling of Goods) Rules, 2007.

The Weights and Measures (Sale and Labelling of Goods) Rules, 2007, in these Regulations referred to as the principal Rules are amended by substituting for Schedule 1, the following—

GOODS TO BE SOLD BY WEIGHT

- 1. Human food with exception of
 - (a) unprepackaged petty quantities sold at a price not exceeding fifty shillings;
 - (b) food items sold by number;
 - (c) food items indicated in Schedules 2,3,4 and 6 when sold under the provisions of those Schedules;
 - (d) food items sold in an open 20-litre measure of capacity on premises not normally used for trade.
- 2. Aerosols.
- 3. Air fresheners in solid form.
- 4. Edible cooking fat, margarine and ghee.
- Animal and pet food.
- 6. Barley.
- 7. Biscuits and chocolate bars.
- 8. Breakfast cereals, cereal preparations for feeding babies, rice, pulses.
- 9. Cashew nuts in shell, cocoa bars, cocoa powder, coffee beans, coffee and roasted coffee beans or ground pure, mixtures and instant condensed or evaporated, dried beans, dried peas and similar pulses, groundnuts, and peanuts, maize, maize grains and maize bran, millet, wimbi, simsim and sorghum, wheat flour wheat grains and wheat bran.
- 10. Castor seeds and sunflower seed.
- 11. Cement.

- 12. Cleaning and scouring powder; soap flakes, soap powders; detergents other than liquid detergents not exceeding 5 liters.
- 13. Dentifrices.
- 14. Liquid petroleum gas.
- 15. Lubricating greases.
- 16. Nails.
- 17. Sand and other ballast except when sold by volume.
- 18. Sisal.
- 19. Sold fertilizers, agricultural liming material and agricultural salt.
- 20. Solid insecticides and solid fungicides.
- 21. Solid paste polishes and dressing analogous to solid paste polishes except shoe polish.
- 22. Tobacco including snuff.
- 23 Honey and sugar.
- 24. Soap including laundry bars soap and toilet soap in form of bars, tablets or cakes.
- 25. Lead.
- 26. Glucose.
- 27. Mushrooms.
- 28. Sauces, ketchup and other spreads being meat extracts vegetable extracts and fish paste.
- 29. Tea including herbal and flavoured except when packed in the form of tea bags.
- 30. Cosmetics in solid form including jellies.

- 31. Dairy products including milk powder, yoghurt, ice cream, butter and cheese, except those in liquid form.
- 32. Instant formula in solid powdered form.
- 33. Meat products including bacon, sausages, frankfurters and ham.
- 34. Potato and banana crisps.
- 35. Wood charcoal briquettes."

3. Amendment of Schedule 2.

Schedule 2 is amended—

- (a) in paragraph 11 by including "sweets.";
- (b) by inserting immediately after paragraph 11, the following paragraphs—
 - "12. Biscuits in transparent package.
 - 13. Cakes.
 - 14. Sugar bags.
 - 15. Tea bags."

4. Amendment of Schedule 3

Schedule 3 is amended—

- (a) in paragraph 4 by including "alcoholic beverages including beer and stout."; and
- (b) in paragraph 10 by including "cosmetics in liquid form."

5. Amendment of Schedule 4

Schedule 4 is amended in paragraph 6 by including "yoghurt"

6. Amendment of Schedule 5

Schedule 5 is amended by inserting immediately after paragraph 9, the following paragraphs—

- "10. Toilet paper.
 - 11. Wood including ply wood, ceiling boards and other wood boards.
 - 12. Steel for the reinforcement of concrete.
 - 13. Mattresses."

7. Amendment of Schedule 6
